3. SAH Workshops and Meetings Attendance/Report out

Anuj completed SAH training. 25-30 hours. 8 sections and 8 quizzws and test at the end. Responsiilites of SAH's are enormous. SAH's have to start investing in their administrative capacity

Roundtable with NS Labour, Skills & Immigration in NG. (Mark,Jack attended). Gave rosy picture of people moving to NS. Refugees were not on the radar. They don't have

a refugee portfolio. Looking at a narrow range of people. Skills, money. Said they'd have another and invite Minister Lore (housing) for next meeting. We do not have back-up housing in Antigonish-Guysborough Karen talking to organizations. Jack thinks to keep this separate from Council. County could require Mt Cameron to make 1/10 townhouses affordable. Municipalities are not doing housing inspections for "rooming" houses, and houses that are grandfathered in.

Organized for Syrian children to attend Keppoch event.

6. REQUEST: Anuj would like protocol for who gets cc'd on what topics. Maria and Eric will look at this in September policy group

Noreen Verberg. Asked if SAFE interested in participating in her exploratory, qualitative study about refugee newcomer students who are dealing with pre- and post-migration issues related to academic success.

Will involve interviews with students, school personnel and sponsor groups. Looking at factors affecting success.

In the literature no academic work on impact of volunteer support groups on refugee student success in rural areas. What are schools and sponsor groups. SAFE can request something in return.

Jack participated in the past and will be our representative this time.

350 communities; 24 urban centres. Start in spring.

Adam Perry: Rural Stettlement Policy development. (Noreen will send document) Would like SAFE to participated in symposium. Credit for prior learning. Summer 2024.
