# 1) Minutes and Business arising from Meeting July 20, 2023

## 2) Financial Report (Sheila) and fundraising

Sheila reported on financial status

Confirmed that with our A status, we only have to complete a simpler financial review, not an audit, for next 5 years

Decision: Financial statement adoption moved by Sheila, 2<sup>nd</sup> Harry

Fund raising campaign is ready to launch on September 15/16<sup>th</sup> (direct email, personalized to previous donors, social media blast with support from Dan Austen), Canada Helps, faculty listserve, board members reach out to family/friends) Fundraising goal is \$20,000 between Sept 15<sup>th</sup> and Oct 15<sup>th</sup>. Money to bring 2 BVOR families. Receipt for donations over \$25 Discussion of how we should use the money we raise.

Shapiro Foundation might be a good corporate donor opportunity.

Action:

Bronwen will ask families if they have pictures that they would be okay with having on social media

SAFE will take responsibility for sponsoring 2 BVOR families over the coming 2-3 years Policy group to look at developing parameters for deciding how to spend the money we raise. Anuj will send out email asking board members how they think funds raised should be used.

## 3) SAFE Sponsorship Applications/Updates (Harry):

#### Action:

Mike could arrange for delivery of new furniture to Somers Rd storage and have Almohamed /Alahmad family meet there to exchange/take items.

Agenda item for October: have 1 storage space for all Antigonish refugee families?

#### Decisions:

We need a formal process for sponsors to follow when making sponsorship requests, even before we look at the application. Do we need a single contact point for requests?

We need a formal process for how we choose families for a given year, given limits set by federal govt.

#### Actions:

Mark will put together check list for determining family sponsorship; board to review Karen will work with Dan Austen to take down sponsorship request form on web site.

# 4) SAFE as SAH Organizational Assessment Results

Assigned "Plan A" Only have to do self-assessment after 5 years

5 year agreement to be signed by Oct 10 2023

Evaluators recommend we focus on the following before next assessment in 5 years

- 1. Enhanced assessment and screening of potential partners
- 2. Establish a process of training for CG's and/or Co-Sponsors
- 3. Establish a process of direct outreach with sponsored newcomers to ensure support is being provided

SAFE could renew request to other Community Groups to sit in on 6 month check-ins; we were doing this, but can do it again. Challenges with translator. Need more direct communication between SAFE member and family members. We could hire translators (\$20/hour) and require them to follow translation rules Might be worth hiring a prof translator to meet with one of our members at month 9.Ask ISANS (Mark) Not just Arabic speakers
